VOTER REGISTRATION

The deadline to register to vote is the 21st day before an election.

Registering to Vote

To vote in Oregon you need to be registered in the county where you reside. You can register if you can answer yes to these three questions:

- Are you a resident of Oregon?
- Are you a U.S. citizen?
- Are you at least 16 years of age?

If you are 16 or 17 years of age, you will not receive a ballot until an election occurs on or after your 18th birthday.

How to register

You can register to vote online at www.oregonvotes.gov or you can get a voter registration card at any of the following places:

- any county elections office
- the Secretary of State's office
- some state agencies such as the Division of Motor Vehicles
- a voter registration drive

You can fill the card out in person or send it in by US mail. You can also print out a registration card online at www.oregonvotes.gov.

Updating your voter registration

Once you have registered, you are responsible for keeping your information up to date. You can do this online at www.oregonvotes.gov or by completing and returning a voter registration card with the new information.

Assistance in Marking Ballot; Allowances and Limitations

Any voter who, due to a disability or inability to read or write, is unable to mark their ballot may receive assistance. The assistance is provided either by two persons of different political parties provided by the county clerk or by some other person chosen by the voter. Any person assisting a voter must follow the direction of the voter as to how to vote the ballot. Also, the person assisting the voter must not afterwards give out any information about how the voter voted. Additionally, a person may not provide such assistance if they are an employer of the voter or an agent of the employer. Also, a person may not provide such assistance if they are an officer or agent of a union of which the voter is a member. (ORS 254.445)

Measure 15-221 Eagle Point School District 9

Ballot Title

15-221

Bonds to add classrooms, relieve overcrowding, improve safety and security

Question: Shall District add classrooms, repair, update schools, improve safety and security; issue \$58,295,000 general obligation bonds; receive \$4,260,706 state grant? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

Summary: Eagle Point School District 9 seeks bonds to add classrooms to relieve overcrowding, update schools, and improve safety and security. The District has been awarded a \$4,260,706 state grant available only if the bonds are approved.

Bonds will be used to finance capital costs throughout the District, including:

- Replace Elementary classroom building at Shady Cove School
- Add classrooms at EPHS, EPMS, White Mountain MS, Eagle Rock ES, Hillside ES
- Improve traffic flow for student safety at EPMS, Eagle Rock ES, and Table Rock ES
- Upgrade security, fire panels, and lighting
- Construct gymnasium at Hillside ES
- Add multi-use spaces at middle schools
- Renovate locker rooms at EPHS and restrooms at Table Rock ES
- Add covered outdoor areas
- Improve playgrounds

Bonds would mature in 21 years or less from date of issuance. If approved, the tax rate is estimated to be \$1.30 per \$1,000 of assessed value, 34 cents less than the rate paid on the District's prior bond issue. Actual rates may vary based upon interest rates and changes in assessed value.

Explanatory Statement

Eagle Point School District's proposed \$58,295,000 bond would provide funds to add classrooms to address crowding and future growth, enhance the learning environment and improve safety and security.

The District encompasses the communities of Eagle Point, Shady Cove and White City, serving nearly 4,000 students in nine schools. Enrollment is approaching capacity throughout the District, and continued growth is forecast as new construction continues. The city of Eagle Point has averaged about 40 new homes per year over the past decade and has already issued land use approvals for over 300 new homes to be built over the next several years. The communities of White City and Shady Cove together are averaging 70-80 new homes per year.

The proposed bond projects were identified by the District Facilities Committee, which first reviewed and assessed District facilities in 2022. The committee reconvened in 2023, prioritizing and reducing the original list of projects to those it considered most critical.

Proposed projects

The proposed bond is expected to finance projects throughout the District, including:

- Shady Cove School: Replace elementary building. It was constructed in 1928 and has failing operating systems, is approaching student capacity, and would cost more to repair than replace.
- Eagle Point HS: Add classrooms, upgrade fire protection systems, repair and replace perimeter doors, repave parking lots, upgrade locker rooms, install gate for more secure campus.
- Eagle Point MS: Add classrooms, replace door sensors, add multi-use space for PE, STEAM/CTE classes, wrestling and after-school programs, improve traffic flow for student drop-off and pick up.
- White Mountain MS: Add classrooms, add multi-use space for PE, STEAM/CTE classes, wrestling and after-school programs.
- Eagle Rock ES: Add classrooms, expand playground area, add outdoor covered area, improve traffic flow for student drop-off and pick up.

- · Hillside ES: Add classrooms, gymnasium and covered outdoor area.
- Table Rock ES: Improve traffic flow for student drop-off and pick up, upgrade fire protection systems, add noise reduction between accordion walls, remodel restrooms, upgrade lighting, update playground equipment.
- Upper Rogue Center for Educational Opportunities: Add covered outdoor area, improve gym and office space.

Bond cost

The bond is estimated to cost property owners \$1.30 per \$1,000 of assessed value and would be repaid over 21 years. This estimated rate is 34 cents less than the rate of the District's previous bond which expired in 2020. Bond funds could only be used for capital costs, not operating costs.

\$4,260,706 matching grant

If the bond passes, Eagle Point School District would receive a \$4,260,706 grant from the Oregon School Capital Improvement Matching (OSCIM) program to use for bond projects. The District would not receive the grant if the proposed bond doesn't pass.

Local jobs

The District would structure portions of the bond projects into smaller contracts that local contractors could bid on.

Accountability and informing the public

The School Board would appoint a citizen oversight committee to monitor the progress, schedule and costs of the bond. That committee would report back to the School Board on a regular basis.

Argument in Favor

In recent years our community has experienced rapid growth while maintaining our small-town feel. Our schools reflect our community, and we want to give our kids the best chance to succeed now and in the future. The key to their success is having a great experience while in our schools. For that to happen they need an atmosphere that enables both students and teachers to thrive.

Our district staff has done so well maintaining our older buildings that some might think things are just fine. They're not. Shady Cove elementary is 90 years old and repairs are no longer economically viable. Classroom space at all schools is too tight to allow for the developments that are being built. Drop off and pickup areas are too congested, time consuming, and unsafe. The fire protection systems at the high school and Table Rock Elementary are too old for improvement. The perimeter doors at multiple schools are not secure. We do not have sufficient space for our middle school STEAM/ CTE, wrestling, and after school programs. Some of our schools do not have a gymnasium on the property. Our high school locker rooms are in serious need of upgrades to facilitate a better sports program.

The cost we will pay now will save us money in the future. The cost of not doing something now will affect the educational experience our kids will have moving forward through school and afterwards.

The district has worked hard to improve and build recently (Agriculture Science, TRE modular, gym floors) to show a high level of responsibility and soundness to spending our tax dollars.

Creating and improving our school facilities is critical to the growth, development, and character of a community. Our community is worth investing in.

Please join the school board in voting yes with Friends of D9 Schools for this bond.

We at Club West wrestling urge a Yes vote on Measure 15-221, the District 9 School Bond Levy. Our Club West board members have been involved in the wrestling community for over 50 years, as Coaches, Athletes, or Parents of Athletes. One thing our programs are missing that other schools have is the dedicated wrestling rooms at the Middle School level.

The 2002 fire that destroyed Eagle Point Junior High School also destroyed the only middle school wrestling room in Eagle Point School District 9. For most of the past 21 years middle school wrestling students have been practicing on mats rolled out on cafeteria floors, surrounded by large picture windows, open hard floors, and cafeteria tables. There have been head injuries, shoulder and elbow injuries and knee injuries due to the lack of wall pads that surround a properly constructed wrestling room. The unsafe practice facilities do not meet the requirements of state OARs, school district policies and National Coaches Associations policies for ensuring student athlete safety. This school bond measure will provide a multi-use facility that will provide Eagle Point Middle School and White Mountain Middle School with classrooms for Physical Education, STEAM/Career Technical Education and other classroom space during the day. This facility will also provide a safe space for after-school activities, which includes wrestling. Safe facilities for students need to be a top priority.
